## INSTALLATION TIPS

Never use saddle valve for connection.

Use 3/8" water line.

Install vertically with cartridge hanging down.

Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.

Flush 2CB5-GW cartridge by running water through system for five (5) minutes at full flow.

## OPERATION TIPS

Change filter cartridge on a regular six (6) month preventative maintenance program.

Service flow rate must not exceed 0.5 gpm (1.9 Lpm).

Always flush the filter cartridge at time of installation and cartridge change.

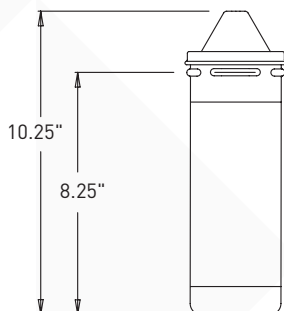
